ANIMAL CARE - THE SACRAMENTO ZOO IS PROUD TO HAVE AN OUTSTANDING COLLECTION OF ANIMALS TO EDUCATE AND INSPIRE OUR COMMUNITY. THE ZOO IS HOME TO 450 ANIMALS REPRESENTING 123 SPECIES. OF THAT NUMBER, 38 SPECIES ARE CONSIDERED CRITICALLY ENDANGERED, ENDANGERED OR VULNERABLE BY THE INTERNATIONAL UNION FOR CONSERVATION OF NATURE (IUCN). OF THE SPECIES HOUSED AT THE ZOO, 59 ARE MANAGED COOPERATIVELY AS PART OF THE ZOO'S PARTICIPATION IN PROGRAMS OF THE ASSOCIATION OF ZOOS AND AQUARIUMS (AZA).

BIRTHS AT THE ZOO THIS YEAR INCLUDED SEVERAL ENDANGERED AND CRITICALLY ENDANGERED SPECIES INCLUDING MOST NOTABLY, THE BIRTH OF A CRITICALLY ENDANGERED SNOW LEOPARD CUB, COCONUT. BORN ON MAY 6TH, COCONUT, WHILE
