OF THAT NUMBER, 41 SPECIES ARE CONSIDERED CRITICALLY ENDANGERED, ENDANGERED OR VULNERABLE BY THE INTERNATIONAL UNION FOR CONSERVATION OF NATURE (IUCN). OF THE SPECIES HOUSED AT THE ZOO, 57 ARE MANAGED COOPERATIVELY AS PART OF THE ZOO'S PARTICIPATION IN PROGRAMS OF THE ASSOCIATION OF ZOOS AND AQUARIUMS (AZA).

A NEW SPECIES TO THE SACRAMENTO ZOO IN 2019 WAS THE OKAPI, A RARE SPECIES OF FOREST GIRAFFE THAT ARE ONLY FOUND IN THE FOREST OF THE DEMOCRATIC REPUBLIC OF CONGO. SACRAMENTO ZOO IS ONE OF ONLY THREE
