ANIMAL CARE - THE SACRAMENTO ZOO IS PROUD TO HAVE AN OUTSTANDING COLLECTION OF ANIMALS TO EDUCATE AND INSPIRE OUR COMMUNITY. THE ZOO IS HOME TO 463 ANIMALS REPRESENTING 127 SPECIES. OF THAT NUMBER, 41 SPECIES ARE CONSIDERED CRITICALLY ENDANGERED, ENDANGERED OR VULNERABLE BY THE INTERNATIONAL UNION FOR CONSERVATION OF NATURE (IUCN). OF THE SPECIES HOUSED AT THE ZOO, 57 ARE MANAGED COOPERATIVELY AS PART OF THE ZOO'S PARTICIPATION IN PROGRAMS OF THE ASSOCIATION OF ZOOS AND AQUARIUMS (AZA).

MEMBERSHIP AND VISITOR SERVICES - 2020 WAS A CHALLENGING YEAR FOR THE ENTIRE WORLD AND THE SACRAMENTO ZOO IS NO DIFFERENT. THE ZOO CLOSED TO THE PUBLIC ON TWO OCCASIONS IN 2020 AS A RESULT OF PUBLIC HEALTH ORDERS THAT WERE ISSUED IN RESPONSE TO THE COVID-19 PANDEMIC. DESPITE THESE MANDATORY CLOSURES WHICH OCCURRED MARCH 14 THROUGH JUNE 12, 2020 AND DECEMBER 8, 2020 THROUGH JANUARY 15, 2021, THE ZOO ENTERTAINED AND EDUCATED 277,356 VISITORS.

IN 2020 WE DID THREE VIRTUAL CAMPS FOR 92 CHILDREN, AT THAT POINT THE FAMILIES WERE STILL AT HOME BUT COULD VISIT THE ZOO VIRTUALLY. WE ALSO BEGAN OUR VIRTUAL CLASS PROGRAMMING FOR APPROXIMATELY 1,050 SCHOOL CHILDREN AND FAMILIES THROUGH OUR ZOO TO YOUR VIRTUAL PROGRAM.

ONCE IT WAS SAFE TO HAVE VISITORS BACK ON ZOO GROUNDS, WE REINSTATED OUR BEHIND-THE-SCENES TOURS. OVER 250 PEOPLE PARTICIPATED IN THIS
